
The Longest Day of Nelson

August 24-26, 2007

Nelson Ledges Road Course, Garrettsville, OH

1. ENTRY INFORMATION

- 1.1. **Event:** The Eighteenth Running of the “Longest Day of Nelson” *24 Hour Endurance Event* to be held at Nelson Ledges Road Course, a 2-mile asphalt course located in Garrettsville, OH. This event is sanctioned by the Neohio region of SCCA and governed by the *2007 SCCA General Competition Rules and Category Specifications*, “FasTrack” amendments, the Neohio Regional Class Rules and these Supplementary Regulations.
- 1.2. **Race Length:** The race length is the distance covered by the overall winning car in the 24 hours beginning when the green flag drops (at approximately 3:00 PM on Saturday, August 25, 2007 and ending when the overall lead car (still running) crosses the finish line after 24 hours.
- 1.3. **Cost:** The cost per team is \$1200.
- 1.4. **Classes:** Eligible classes are: AS, ITR, ITA, ITB, ITC, ITE, ITS, ITH, SSB, SSC, SM, SRF, SPD, SPU, SPO, T1, T2 and T3.
 - 1.4.1. SPO, SPU, SPD, ITH and ITE are subject to approval by race organizers and must follow the Neohio Regional Class Rules. These rules are available from the Neohio web site www.neohio-scca.org, and the Nelson Ledges web site www.nelsonledges.com.
- 1.5. **Teams:** Entry to this event is limited to 45 cars on a *first come, first serve* basis.

Note: We will be starting 50 cars; the 5 additional spots are for race organizer’s promotional purposes.

 - 1.5.1. Each entry may include only one car and up to twenty personnel including drivers, crew members, entrant, and Designated Team Representatives (see section 1.5.4). Additional crew passes are available for \$20 each if prepaid or \$30 at track registration.
 - 1.5.1.1. A team may have no more than 6 drivers.
 - 1.5.2. **Entrant:** Each team must designate an *Entrant* who is the contact person both pre- and post-event. This person must be designated on all paperwork and communication. The Entrant and the Team Name are the only proper identifications for a team.
 - 1.5.2.1. All correspondence with Neohio Region must reference the entrant by name and the Team Name.
 - 1.5.2.2. The Entrant must be an SCCA member in good standing and must have a valid e-mail address.
 - 1.5.2.3. The Entrant must be one of the twenty eligible team members on the *Team Entry* form. The Entrant cannot attend as over-crew.

2. ENTRY

2.1. Intent to Run:

2.1.1. Intent to run forms will be accepted from February 26, 2007 through June 4, 2007. Any form received before February 26, as indicated by the postmark, will be returned to sender.

2.1.2. Each Intent to Run must include a payment of \$300 towards their entry.

2.1.3. Each Intent must also include the logbook number of the car to be raced. If a logbook number is not available, the Vehicle Identification Number (VIN) may be used. In the event of damage or other circumstances, the team may substitute a different car only with the permission of the registrar. This may require documentation and is to prevent the selling of entries.

2.1.4. Entries will be accepted in the order they are received and are limited to 45 cars. Entries beyond 45 will be kept on a waiting list.

2.2. The entry fee is \$1200. Must be paid in full by June 4, 2007

2.2.1. Entries paid in full by April 16, 2007 will receive a \$250 discount on their entry. (\$950 total)

2.2.2. Late Entry: Entries submitted after June 4, 2007 must pay a late entry fee of \$300 (\$1500 total).

2.3. All entry forms must be submitted by U.S. Mail, No Signature Required, or other traceable carrier (UPS, Fed-Ex), the carrier's postmark will determine whether or not an entry deadline is met.

2.4. A \$50 charge will be assessed to a team for any returned/NSF check.

2.6. Refunds and Cancellations:

Cancellation request may be by telephone, but must be followed up in writing. Phone notification must be received by June 4, 2007. Full refunds will only be given if there is an entry waiting on the waiting list. Otherwise a refund will be given less the \$300 Intent to Run payment. Late Entries are NON-REFUNDABLE.
